Tree sizes are averages based on field estimates, actual sizes will vary larger or smaller.

Sale is located along the Stony Grade, access is direct. Based on field visit in December 2023 100% is affected by SBW. All standing dead Balsam Fir and Spruce has been appraised as biomass. Shallow soils and slow drainage has relegated operations to frozen conditions only, and the Black Ash is only accessible by freezing a swamp.


