# **HARVEST SPECIFICATIONS**

# **Cutting and Felling:**

- Harvest aspen, white spruce, balsam fir, paper birch, and norway pine. Maple is optional and can be harvested through the added timber process.

#### Cutting and Felling (continued):

- Reserve Island is painted south of the heffelfinger SFR. On the north side of Heffelfinger SFR, reserve an average 6 paper birch per acre.

- Reserve all non-hazardous snags.

#### Season of Operations:

- Conduct sale operations on dry or frozen soil conditions only, except with written permission from State.

## Slash Disposal:

- Distribute slash across the site in piles no larger than 20' by 20'. Piling slash at the landing is approved.
- Keep Heffelfinger State Forest Road free of logging residue.
- Biomass harvest is allowed on this permit. An Added Timber Agreement is required.

# Site, Soil, and Water Protection:

- If site damage becomes apparent, alter or cease operations and contact State.

# Landings, Roads, and Trails:

- The location and construction of all roads and landings must be pre-approved by the State.
- Post "Trucks Hauling" signs 200 feet beyond either end of road/trail section being used.
- Skidding prohibited on forest roads.

## Sale Conditions:

- Access is across State land.

# Marketing and Special Conditions:

Aspen Species Pulp & Bolts: Average 10" DBH and 4 sticks Balsam Fir Pulp & Bolts: Average 9" DBH and 3 sticks Maple Species Pulpwood: Average 10" DBH and 2 sticks Norway Pine Woodsrun Sawtimber (Softwood only): Average 16" DBH and 6 sticks Paper Birch Pulpwood: Average 11" DBH and 3 sticks White Spruce Pulp & Bolts: Average 10" DBH and 4 sticks

Tree sizes are averages based on field estimates, actual sizes will vary larger or smaller.

This sale is located approximately 7 miles down the Heffelfinger SFR from Finland. Area is impacted by spruce budworm, sale is cruised to harvest live balsam and spruce trees based on field visit in June 2024.

Sale area has some drainages and low areas on the north side of Heffelfinger SFR, it would take improvements on skid trails to harvest during non-frozen soil conditions. Sale area on the south side of Heffelfinger SFR has potential for late summer non-frozen soil conditions harvesting.

Price Adjustments apply to aspen and NP. All other species have -35% Lake County discount applied.


